Bourse Contract for ARIPEX 2015

This agreement between ARIPEX 2015 sponsored by the Arizona Federation of Stamp Clubs (AFSC) and the Dealer applies to the philatelic exhibition and bourse to be held at the Mesa Centennial Hall, 263 North Center Street, Mesa, Arizona, on February 20 – 22, 2015. The show committee will provide a license to use space in the following configurations:

1. For a fee of \$575.00, ARIPEX 2015 agrees to provide the dealer one straight eight-foot display table x, 30” depth and one eight foot back-up table x 24” depth; or
2. For a fee of \$750.00, ARIPEX 2015 agrees to provide the dealer a corner booth with two eight-foot display tables x 30” depth and one eight foot back-up table x 24” depth

A limited number of commercial grade locking metal storage cabinets can be provided at a cost \$100.00 each and must be contracted for and paid for no later than January 31, 2015.

Payment Schedule

Contract signing: \$ 200.00 minimum initial deposit with balance paid in full by November 30, 2014

Special Discount: \$75.00 discount if (1) FULL PAYMENT is received at contract signing and (2) Signed contract is submitted to ARIPEX 2015 prior to November 30, 2014. NO EXCEPTIONS WILL BE GRANTED.

Each dealer must be a member in good standing of **A.S.D.A., I.F.S.D.A., A.P.S., N.S.D.A.** or other recognized Philatelic organization approved by the AFSC. AFSC reserves the right to deny exhibition space to any dealer without challenge. Prior to contract acceptance, AFSC reserves the right to re-assign booth numbers at its sole discretion.

No person who is under suspension or has previously been expelled from A.S.D.A., N.S.D.A. or A.P.S., or denied membership for cause, other than insufficient experience, may be allowed to act as a dealer or otherwise appear behind a dealer’s table. A person who has been reinstated by either organization may appeal to ARIPEX to be admitted.

Dealer warrants that the licensed space provided will be used exclusively by said dealer for the purchase, sale, or trade of philatelic properties, related material and/or supplies.

Dealer agrees to maintain his/her space in an orderly and professional manner and agrees to leave in place all tables, equipment, signs and markers defining the assigned space.

Licensed space may be shared by no more than two dealers with **written permission of the ARIPEX 2015 Bourse Chairperson. Approval must be obtained no later than December 31, 2014 so signs can be prepared.**

No refunds will be granted after September 30, 2014 for no shows or cancellations unless the table can subsequently be re-sold at an equal or greater price.

Dealer agrees that during the hours the exhibition is open to the public; either the dealer or the dealer's agent will be in attendance at the booth. The bourse will be open to the public:

Dealer set-up will be from 1PM-7PM, Thursday, February 19, 2015. Move out will not begin before 3PM on Sunday, February 22, 2015 and must be completed by 4PM. Booth must be open for business each day until the end of the show.

Dealer agrees to hold ARIPEX 2015 harmless from any liability or claim for personal injury, property damage, or loss by theft or other causes, and to indemnify ARIPEX 2014 for any such loss or claim concerning the dealer, the dealer's agents, employees, associates, spectators, and customers. Dealer further agrees that ARIPEX 2015 is merely providing the bourse space and in no way will be responsible, or a party to disputes or controversies regarding the sales, purchases and/or representations made by the dealer.

Dealer agrees to comply with all rules and regulations of the exhibition, and local and state governments. Unethical dealings or other conduct that discredits the exhibition will be cause for eviction from ARIPEX 2015.

Dealer agrees to obtain a sales tax license from the City of Mesa Arizona and present such license to the bourse chairman, Robert Freeman no later than January 1, 2015. The bourse chairman will have all necessary material and will provide such to aid the dealer in obtaining the license.

ARIPEX 2015 agrees to provide 24-hour uniformed guard service from 1 PM, Thursday February 19, 2015 until 4PM, Sunday, February 22, 2015.

This agreement is understood to apply only to ARIPEX 2015 and does not bind in any way either the dealer or the AFSC to any future exhibitions.
