BOURSE CONTRACT for ARIPEX 2020

ARIPEX 2020 sponsored by the Arizona Federation of Stamp Clubs (AFSC) and the Dealer will be held at the Mesa Centennial Hall, 201 North Center Street, Mesa, Arizona 85201. The show committee will provide a license to use space in the following configurations: ARIPEX 2020 agrees to provide the dealer a straight eight-foot display table and an eight foot

ARIPEX 2020 agrees to provide the dealer a corner booth with two eight-foot display tables and a table. Locking metal storage cabinets can be provided at a cost \$100 each and must be ordered for no later than January 31, 2020.

Contract signing in order to secure same or equivalent table location at ARIPEX 2020. Must be completed by November 30, 2019.

10% discount if full payment is received at contract signing and signed contract is received by November 30, 2019. No exceptions will be granted.

Dealer must be a member in good standing of A.S.D.A., I.F.S.D.A., A.P.S., N.S.D.A. or other recognized organization approved by the AFSC. AFSC reserves the right to deny exhibition space to any dealer who does not accept the contract. After contract acceptance, AFSC reserves the right to re-assign booth numbers at its sole discretion.

Dealer who has been suspended or has previously been expelled from A.S.D.A., N.S.D.A. or A.P.S., or denied membership, other than insufficient experience, may be allowed to act as a dealer or otherwise appear at the show. A person who has been reinstated by either organization may appeal to ARIPEX to be considered for membership.

The licensed space provided will be used exclusively by said dealer for the purchase, sale, or display of stamps, related material and/or supplies.

Dealer must maintain his/her space in an orderly and professional manner and agrees to leave in place all signs and markers defining the assigned space.

AFSC reserves the right to reassign table location.

Table space will be shared by no more than two dealers with **written permission of the ARIPEX 2020 Bourse Committee. Written permission must be obtained no later than December 1, 2019 so signs can be prepared.**

Table space is not to be rented after September 30, 2019 for no shows or cancellations unless the table can be sold at an equal or greater price.

During the hours the exhibition is open to the public; either the dealer or the dealer's agent will be responsible for the booth. The bourse will be open to the public:

Friday, February 14 10:00 AM - 6:00 PM

Saturday, February 15 10:00 AM - 6:00 PM

Sunday, February 16 10:00 AM - 3:00 PM

Move out from 1PM-7PM, Thursday, February 13. Move out will not begin before 3PM on Sunday,

and must be completed by 4PM. Booth must be open for business each day until the end of the show.

ARIPEX 2020 harmless from any liability or claim for personal injury, property damage, or other losses caused by the dealer, the dealer's employees, associates, spectators, and customers. Dealer further agrees that ARIPEX 2020 is not responsible for the use of the bourse space and in no way will be responsible, or a party to disputes or controversies arising from purchases and/or representations made by the dealer.

Dealer must comply with all rules and regulations of the exhibition, and local and state governments. Unethical behavior or conduct that discredits the exhibition will be cause for eviction from ARIPEX 2020.

Dealer must obtain a sales tax license from the City of Mesa Arizona.

ARIPEX 2020 will provide 24-hour uniformed guard service from 1 PM, Thursday February 13, 2020 until Sunday, February 16, 2020.

This contract is understood to apply only to ARIPEX 2020 and does not bind in any way either the dealer or the AFSC at other exhibitions.

This agreement between ARIPEX 2020 sponsored by the Arizona Federation of Stamp Clubs (AFSC) and the Dealer applies to the philatelic exhibition and bourse to be held at the Mesa Centennial Hall, 201 North Center Street, Mesa, Arizona, on February 14-16, 2020. The show committee will provide a license to use space in the following configurations:

- For a fee of \$650, ARIPEX 2020 agrees to provide the dealer a straight eight-foot display table and an eight foot back-up table; or
- For a fee of \$825, ARIPEX2020 agrees to provide the dealer a corner booth with two eight-foot display tables and an eight foot back-up table. Locking metal storage cabinets can be provided at a cost \$100 each and must be contracted for and paid for no later than January 31, 2020.

Payment Schedule

\$200 Deposit due at Contract signing in order to secure same or equivalent table location at ARIPEX 2020.
Balance paid by November 30, 2019.

Special Discount: \$100 discount if full payment is received at contract signing and signed contract is submitted to ARIPEX 2020 on or before November 30, 2019. No exceptions will be granted.

- Each dealer must be a member in good standing of A.S.D.A., I.F.S.D.A., A.P.S., N.S.D.A. or other recognized Philatelic organization approved by the AFSC. AFSC reserves the right to deny exhibition space to any dealer without challenge. Prior to contract acceptance, AFSC reserves the right to re-assign booth numbers at its sole discretion.

• No person who is under suspension or has previously been expelled from A.S.D.A., N.S.D.A. or A.P.S., or denied membership for cause, other than insufficient experience, may be allowed to act as a dealer or otherwise appear behind a dealer's table. A person who has been reinstated by either organization may appeal to ARIPEX to be admitted.

- Dealer warrants that the licensed space provided will be used exclusively by said dealer for the purchase, sale, or trade of philatelic properties, related material and/or supplies.

- Dealer agrees to maintain his/her space in an orderly and professional manner and agrees to leave in place all tables, equipment, signs and markers defining the assigned space.

• ARIPEX 2020 reserves the right to reassign table location.

- Licensed space may be shared by no more than two dealers with written permission of the ARIPEX2020 Bourse Chairperson. Approval must be obtained no later than December 1, 2019 so signs can be prepared.

• No refunds will be granted after September 30, 2019 for no shows or cancellations unless the table can subsequently be re-sold at an equal or greater price.

- Dealer agrees that during the hours the exhibition is open to the public; either the dealer or the dealer's agent will be in attendance at the booth. The bourse will be open to the public:
 - 1) Friday February 14 10:00 AM - 6:00 PM
 - 2) Saturday, February 15 10:00 AM - 6:00 PM
 - 3) Sunday, February 16 10:00 AM - 3:00 PM

• Dealer setup will be from 1PM-7PM, Thursday, February 13. Move out will not begin before 3PM on Sunday, February 16 and must be completed by 4PM. Booth must be open for business each day until the end of the show. • Dealer agrees to hold ARIPEX 2020 harmless from any liability or claim for personal injury, property damage, or loss by theft or other causes, and to indemnify ARIPEX 2020 for any such loss or claim concerning the dealer, the dealer's agents, employees, associates, spectators, and customers. Dealer further agrees that ARIPEX 2020 is merely providing the bourse space and in no way will be responsible, or a party to disputes or controversies regarding the sales, purchases and/or representations made by the dealer.

• Dealer agrees to comply with all rules and regulations of the exhibition, and local and state governments. Unethical dealings or other conduct that discredits the exhibition will be cause for eviction from ARIPEX 2020. • Dealer agrees to obtain a sales tax license from the City of Mesa Arizona.
